- Minutes- October 5, 2021

Mr. Tapia shared the screen and the council reviewed and discussed the Additional Targeted Support and Improvement (ATSI) Report. The report included the following data; enrollment, attendance, chronic absenteeism, office referrals, and suspensions school wide and for our African American and English Learner student populations.
 - School Data Progress Monitoring
Mr. Tapia shared the screen and the committee reviewed and discussed the School Data Progress Monitoring Report. The report included a comparison of the Achieve 3000 Lexile Scores for students in grades 3rd-6th for school years 2019, 2020, and 2021 as of September.

Mr. Tapia reported that the October Reading Challenge was a great success. The goal was for our students to complete 1,500 Accelerated Reader tests between October 1st and October 25th. By October 25th they completed 2,200 tests. Based on this we will be having a November Reading Challenge per classroom. As a motivation those classrooms that meet the goal by November 19th will be getting hot chocolate with marshmallows.

In addition, Nichols School went from number 18th in the District to number 10th due to the number of completed AR tests.
