Downtown School was built in 1997. It sits on 1.96 acres of which 1.26 acres is playground. This school has 14 classrooms, a multi-purpose, music room, learning center and library. The campus has a staff lounge.

The custodial staff adheres to a weekly cleaning schedule that includes classrooms, restrooms, cafeteria and kitchen areas.

The District's Mobile Maintenance Team visits the school site at least twice a year. Maintenance emergencies are addressed immediately. District personnel maintain the grounds at least once every two weeks.

This site also is maintained to ensure a clean, safe, and functional facility as determined pursuant to a Facility Inspection Tool developed by the State of California Office of Public School Construction.

The FACE Liaison recruits, guides, and promotes parents, family and community members to be involved in the multitude of program opportunities at our school. We have many ways for parents and community members to be an integral part of our educational programs and we have a large cadre of faithful volunteers. Downtown School takes pride in saluting America's Veterans during our annual celebration inviting vets related to our students, and from the community in general, to our large, colorful, and honoring event. The Community Partners in Education is another opportunity for us to connect with neighboring businesses and organizations to enhance the educational experience for students and adults alike. We are also connected to many community volunteers through the KCSOS Community Reading Project, offering targeted reading foundational support to second graders. Many volunteer workers come to help in the classroom wherever needed. We truly appreciate all the help and involvement from our volunteers and recognize them annually at Volunteer Appreciation events. As an additional outreach to our downtown community, walking field trips to many of the city offices, museums, and service centers are also scheduled to enrich student learning and make a strong connection to our downtown city area.

We promote effective communication through our web site, Remind text app, the Parent Portal, monthly e-newsletters, flyers regarding upcoming events, global e-mails to all parents, and teacher e-mails regarding student activities and progress to parents. We recognize that parents are a critical aspect of the educational process. School Safety Plan (School Year 2020-2021)

Downtown established its Comprehensive School Safety Plan in 1998. A law enforcement officer specializing in safety provided direction in the establishment of the School Safety Plan. Downtown’s School Safety Plan is current and is updated annually. BCSO and KCSOS developed Emergency Response plans and protocols that we have in place, train all our staff and students with, and practice on a regular basis. Recent reviews of the plan were held with the staff on September 19, 2019, October 17, 2019, and January 23, 2020. The SSC reviewed the CSSP on January 24, 2020 and again reviewed and voted for approval of the Plan on February 28, 2020 . The reviews included the new elements of the BCSO Standard Response Protocol (SRP). Key elements of Downtown’s School Safety Plan include the following: (a) routine and emergency disaster procedures; (b) suspension, and expulsion procedures; (c) teacher notification of pupils with a specific discipline history; (d) child abuse reporting procedures, (e) the district’s sexual harassment policy; (f) school crime data; (g) the student dress code; (h) safe entrance and exit procedures; (i) the civil defense and disaster plan; and (j) discipline rules and procedures. Our overall goal is to maintain a safe and orderly school environment conducive to learning, demonstrating mutual respect for all, and a positive and caring environment.

Professional development is designed to provide continuous learning opportunities for administrators, teachers, and classified personnel. Training opportunities affirm the basic philosophy of education that learning is a lifelong process that contributes to the well-being of the students, teachers, administrators, and community. Professional Development is an essential component of effective instruction and student learning.

All training revolves around identified needs of students and adults for the purpose of the improvement of instruction and increasing content knowledge. Central to all training are student achievement data, district focus areas, the Common Core State Standards, the state adopted standards-based instructional materials, and strategies to effectively teach the academic content standards to all students.

We also provided extensive professional development for Professional Learning Communities through our Service Delivery Model. On-site coaching and support is provided by academic coaches and district specialists for reading/language arts, mathematics, science, writing and social emotional learning. The district provides time and resources for collaboration, planning, and professional development. Additionally, we provided professional development on Multi-Tiered Systems of Support and Support to school and district teams.

Teachers new to the District received four days of professional development prior to the beginning of the school year focused on orientation to District and school site policies and services, Common Core State Standards, classroom management, curriculum and pacing, using technology and setting up the classroom. Teachers in their second year with the District received two days of professional development prior to the beginning of the school year provided by the school site and focused on improving best practices.

New teachers with California preliminary credentials received professional development through the Bakersfield City School District (BCSD) Teacher Induction Program (TIP). The focus of BCSD TIP is being mentored by an experienced teacher, growing in the California Standards for the Teaching Profession (CSTP) and meeting the California Induction standards. The culmination of TIP is the recommendation for the CA Clear Credential. Each TIP teacher was assigned a veteran teacher who served as a mentor. The mentors received on-going professional development in coaching/mentoring strategies, instructional strategies, and guiding cycles of inquiry. Professional development was provided through individual mentoring, monthly meetings, and after-school workshops.

Intern teachers received professional development at monthly meetings focusing on the initial teaching skills of the CSTP including classroom management, lesson planning, assessment, and establishing a climate that is conducive to student achievement. Each Intern was assigned a mentor that provided day-to-day support in these areas as well as advisement toward meeting credential requirements. Mentors received monthly professional development in meeting the needs of Intern teachers. Interns also received coursework and supervision from universities partnered with BCSD to provide the Intern Program.

Teachers on Short Term Staffing Permits (STSPs) were provided mentors and training on beginning pedagogy and best teaching practices. Each teacher on a STSP designed a plan to meet requirements to move to a CA Intern or Preliminary Credential. Support was provided for required testing and BCSD staff worked closely with university partners to ensure teachers on permits were taking prerequisite requirements to move to credentials.

Teachers on Provisional Intern Permits (PIPs) were provided mentors and training on beginning pedagogy and best teaching practices. Each teacher on a PIP designed a plan to meet requirements to move to a CA Intern Credential. Support was provided for required testing and BCSD staff worked closely with university partners to ensure teachers on permits were taking prerequisite requirements to move to credentials.
