## School Facility Conditions and Planned Improvements

Wayside School was built in 1949 and modernized in 1993. It sits on 8.15 acres of which 3.78 acres is playground. This school has 33 classrooms, a multi-purpose center, library, bookroom, two pre-k classrooms, reading lab, learning center, and office room. The campus also has a staff lounge and a workroom.

The custodial staff adheres to a weekly cleaning schedule that includes classrooms, restrooms, cafeteria and kitchen areas.

The District's Mobile Maintenance Team visits the school site at least twice a year. Maintenance emergencies are addressed immediately. District personnel maintain the grounds at least once every two weeks.

This site also is maintained to ensure a clean, safe, and functional facility as determined pursuant to a Facility Inspection Tool developed by the State of California Office of Public School Construction.

#### 2023-24 Opportunities for Parental Involvement

We believe that our parents/guardians are an extremely important and integral part of student learning at Wayside School. Wayside parents/guardians participate in a number of organizations including: School Site Council, District Advisory Committee, District English Learners Advisory Committee, African-American Parent advisory committee, and our Family and Community Engagement program. We provide a variety of educational opportunities for our parents/guardians such as classes in nutrition, navigating the school systems, and parenting skills. Site principal, Mrs. Ventura, holds monthly meetings for parents that cover such topics such as understanding student instructional tools, standards-based instruction, nutrition, developmental growth, and child abuse prevention. These monthly meetings also afford our parents/guardians multiple opportunities to ask questions about how they can effectively collaborate with our school and become active partners with us in the education of their children. Our parent groups organize, sponsor and attend several major activities and events including: Back-to-School Night, field trips, quarterly awards ceremonies, staff Appreciation luncheon, and our end-of-year programs. Wayside has an active and supportive parent community along with a dynamic administrative support staff which work together to provide a full-range of services to learning community. Some of these services include translation, referrals for clothing, emergency food, medical and/or mental health treatment and counseling, other links for families to services in the community, and transportation to such services. Specifically, our children and parents/guardians participate in the Costco Star Readers Program, and Volunteer Center for food baskets at Thanksgiving and Christmas. Wayside has an active Parent Volunteer program and recruits and trains all parents and community members willing to partner with us. Parents can call our school office at (661) 631-5820 to access information concerning participation opportunities.

We have a three-hour After School Program that serves over 150 students each school day. Many opportunities occur each month for our After School parents/guardians to actively participate in such as assemblies on health, transportation, motivation, behavior, and character building. The ASP has three periods a day: homework, art/music, technology, and sports, and also holds fun activities like dances and field trips.

## Professional Development

Professional development is designed to provide continuous learning opportunities for administrators, teachers, and classified personnel. Training opportunities affirm the basic philosophy of education that learning is a lifelong process that contributes to the well-being of the students, teachers, administrators, and community. Professional Development is an essential component of effective instruction and student learning.

All training revolves around identified needs of students and adults for the purpose of the improvement of instruction and increasing content knowledge. Central to all training are student achievement data, district focus areas, the Common Core State Standards, the state adopted standards-based instructional materials, and strategies to effectively teach the academic content standards to all students.

During the 2022-2023 school year, district professional development focused on supporting good first instruction and the use of core instructional materials in all content areas. In preparation of the school year, teachers were offered three full days of professional development sponsored by the district and additional dates at the school sites. Regularly scheduled follow ups and extensions to summer learning were provided throughout the school year. Topics addressed the use of core curriculum to support the Next Generation Science Standards, Foundational Reading Skills, Reading Comprehension, Using Manipulatives, Literature and Problem Solving in Mathematics, Project Based Learning and incorporating technology.

Additional support was provided by academic coaches and district specialists for reading/language arts, mathematics, science, writing and social emotional learning. The district provided time and resources for collaboration, planning, and professional development. Additionally, professional development on Multi-Tiered Systems of Support and Support to school and district teams.

Teachers new to the District received four days of professional development prior to the beginning of the school year focused on orientation to District and school site policies and services, Common Core State Standards, classroom management, curriculum and pacing, using technology and setting up the classroom. Teachers in their second year with the District received two days of professional development prior to the beginning of the school year provided by the school site and focused on improving best practices.

New teachers with California preliminary credentials received professional development through the Bakersfield City School District (BCSD) Teacher Induction Program (TIP). The focus of BCSD TIP is being mentored by an experienced teacher, growing in the California Standards for the Teaching Profession (CSTP) and meeting the California Induction standards. The culmination of TIP is the recommendation for the CA Clear Credential. Each TIP teacher was assigned a veteran teacher who served as a mentor. The mentors received on-going professional development in coaching/mentoring strategies, instructional strategies, and guiding cycles of inquiry. Professional development was provided through individual mentoring, monthly meetings, and after-school workshops.

Intern teachers received professional development at monthly meetings focusing on the initial teaching skills of the CSTP including classroom management, lesson planning, assessment, and establishing a climate that is conducive to student achievement. Each Intern was assigned a mentor that provided day-to-day support in these areas as well as advisement toward meeting credential requirements. Mentors received monthly professional development in meeting the needs of Intern teachers. Interns also received coursework and supervision from universities partnered with BCSD to provide the Intern Program.

Teachers on Short Term Staffing Permits (STSPs) were provided mentors and monthly trainings on beginning pedagogy and best teaching practices. Each teacher on a STSP designed a plan to meet requirements to move to a CA Intern or Preliminary Credential. Support was provided for required testing and BCSD staff worked closely with university partners to ensure teachers on permits were taking prerequisite requirements to move to credentials.

Teachers on Provisional Intern Permits (PIPs) were provided a weekly cohort meeting focused on beginning pedagogy. Two cohort meetings occurred weekly to allow teachers on a PIP to work around university course schedules. Support was provided for required testing and BCSD staff worked closely with university partners to ensure teachers on permits were taking prerequisite requirements to move to credentials.
